NOTIFICATION

Whereas, the second Administrative Reforms Commission constituted by the Government of India in its 12th report titled 'Citizen Centric Administration- The Heart of Governance' has recommended simplifying procedures for self certification provision;

And Whereas, the State Government has deemed it expedient to review the existing requirement of attestation by Gazetted Officers in various application forms and in a citizen friendly initiative, and has decided that the applicants while submitting documents for admission in Educational Institutions, seeking employment in Government Departments and for issuance of other need based Certificates will be permitted to submit self- attested copies of documents, if the applicants are capable of reading, writing and understanding the language in which the documents in question is written and are major and sui juris subject to production of original documents;

And whereas, due attention should be taken that a false attestation or authentication of documents amounts to forgery within the meaning of section 463 read with section 464, 24 and 25 of the Indian Penal Code 1860;

And whereas, the applicant shall also file a self declaration form as per Annexure-A appended with this Notification;

And whereas, the original documents are required to be produced at the final stage or as and when called upon to do so;

Now therefore, with the view to achieve the above objectives, the State Government hereby pleased to introduce self attestation of all documents except the documents like Sikkim Subject Certificate, Certificate of Identification, Residential Certificate and Land Records Certificates/Documents which shall be verified and attested by the District Magistrates/ Additional District Magistrates/Sub Divisional Magistrates or Gazetted Officers from the Land Revenue and Disaster Management Department, Government of Sikkim.

This Notification shall be in supplement to the 'Note' under rule 14 of the Sikkim Government Service (Revised Pay) Rules, 2009 or any rules made subsequently in this behalf.
